To obtain a search of Lake County court records on file with this office, please follow the procedure outlined below:

- **YOUR REQUEST WILL RESULT IN A SEARCH OF LAKE COUNTY, FLORIDA CASES ONLY.** CASES IN ANY OTHER COUNTY OR STATE WILL NOT BE SEARCHED.
- COMPLETE THE ENCLOSED FORM AND SUBMIT TO: RECORDS SEARCHES, CLERK OF THE CIRCUIT COURT, POST OFFICE BOX 7800, TAVARES, FLORIDA 32778.
- PROVIDE A SELF-ADDRESSED, STAMPED ENVELOPE FOR RETURN OF THE RESULTS. IF REQUESTING A FAXED REPLY, PROVIDE FAX NUMBER AND PAYMENT FOR SAME.
- **PAYMENT MUST BE RECEIVED BEFORE SEARCH WILL BE COMPLETED.** CHARGES WILL BE ASSESSED UNLESS *PROOF OF EXEMPTION PER FLORIDA STATUTE IS PROVIDED WITH REQUEST.*

## **COSTS FOR RECORD REQUEST**

- ∞ \$2.00 per name per calendar year. (Ex: If a record check is requested for 5 years on one individual, cost would be a total of \$10.00; if a record check is requested for 5 years on one individual with 2 names, e.g., a married and a maiden name, cost would be \$20.00.) ∞ \$1.00 for fax return of record request.
- ∞ Include postage or a self-addressed stamped envelope with request.
